History Extrajudicial Murders, Deaths in Jail, & Suicide by Blasphemy Suspects (By Mohammad Nafees)

So far, I could find nearly 51 cases wherein blasphemy suspects were either extra judicially murdered or died in jail. The plea taken by the supporters of the blasphemy law at the time of its introduction and even to this date is that this law is to provide legal means for handling blasphemy cases. The history of events show an opposite result since the introduction of this law.
